Carlsbad, CA – New Village Arts (NVA) is proud to announce its upcoming production of the groundbreaking rock musical RENT. Directed by KYM PAPPAS with music direction by ELENA CORREIA and choreography by TAMARA RODRIGUEZ, this bold reimagining of JONATHAN LARSON'S Tony Award— and Pulitzer Prize—winning musical will bring to life the grit, hope, and community of 1990s New York's East Village just in time for the holiday season. Performances on the Ray Charles Stage will run OCTOBER 31ST THROUGH DECEMBER 24TH, 2025 at the Dea Hurston New Village Arts Center in Carlsbad Village. Previews are OCTOBER 31ST THROUGH NOVEMBER 7TH, with an Opening Night champagne reception and Handel's Ice Cream on SATURDAY, NOVEMBER 8TH, 2025.

Jonathan Larson's RENT changed the face of musical theatre, bringing rock music and the struggles of a generation to the Broadway stage. The show follows a group of young bohemian friends as they navigate love, loss, and the height of the AIDS crisis with courage and hope. Featuring iconic and unforgettable songs like "Seasons of Love," "La Vie Bohème," and "Take Me or Leave Me," RENT became a global phenomenon, later inspiring a 2005 film that introduced the story to an even wider audience. More than a musical, RENT is a cultural revolution: a testament to Larson's vision of living and loving without fear.



New Village Arts' production is helmed by an all-star creative team. KYM PAPPAS directs, returning to NVA after directing acclaimed productions such as FUN HOME (2024) and THE HALF-LIFE OF MARIE CURIE (2025), as well as performing in numerous NVA shows. TAMARA RODRIGUEZ, who recently co-choreographed NVA's celebrated production of LA HAVANA MADRID (2025), brings her signature style to the choreography. Making her NVA debut is ELENA CORREIA as music director, guiding Jonathan Larson's iconic rock score with fresh energy and passion.

"RENT is not passive theatre; it requires an act of participation from its audience," says RENT director Kym Pappas. "It is intimate and urgent and demands presence. In these very uncertain and demanding times, it is my hope that it will remind us all to see beyond our differences... to reach out to each other and find community... and choose love, even when it all feels impossible. RENT reminds us that together is the only way we're going to survive."

The design team for RENT brings together a powerhouse of creative talent: CHRISTOPHER SCOTT MURILLO and CARTER VICKERS both return to NVA as Scenic & Props Designers, respectively. MURILLO & VICKERS have collaborated on numerous recent NVA productions including THE MOUNTAINTOP, LA HAVANA MADRID, THE HALF-LIFE OF MARIE CURIE, and many more. The show is also shaped by CURTIS MUELLER as Lighting Designer, and JORDAN GRAY as Sound Designer, with NVA Technical Theatre Manager MARCUS RICO as Sound Engineer. JESS MORENO CAYCHO returns after costuming last season's LA HAVANA MADRID, while local drag queen AMBER ST. JAMES serves as Wig Designer and Show Consultant, ensuring authenticity and flair. JOEL CASTELLAW joins Amber as Show Consultant, helping infuse the production with honesty and heart. KANDACE CRYSTAL joins the creative team as Intimacy Director. The production is guided behind the scenes by NATHAN WAITS as stage manager and JERUEL CANDA+ as assistant stage manager, both dedicated to making this production unforgettable. The production is also supported by ZACHARY ELLIOTT, Scenic Painter, and GREG ERTEL, Master Carpenter.

"RENT endures not only because of the strength of the music and storytelling. It endures because it continues to resonate culturally," says Joel Castellaw, Cultural Consultant. "A brutal epidemic, the scourge of drug addiction, the challenges faced by our LGBTQ+ communities, social stratification leaving people desperate to find housing – these social conditions from 30 years ago are all still with us today, and we continue to need cause to hope that they can be overcome."

RENT will feature an incredible group of onstage artists bringing this iconic musical to life. Recent <u>SDUT</u> <u>Fall Arts Guide featured artist</u> LENA CEJA will captivate audiences in the role of Mimi, returning to the NVA stage after appearing in last season's LA HAVANA MADRID. XAVIER J. BUSH returns in the role of Angel; they last delighted audiences as Cosmo Brown in SINGIN' IN THE RAIN in 2023. Another NVA favorite EBONI MUSE, recognized for her standout performances in THE COLOR PURPLE, LITTLE SHOP OF HORRORS, and SMOKEY JOE'S CAFÉ, will bring brilliance to Joanne. JOSH BRADFORD also returns to NVA



as Roger; he was last seen at NVA ten years ago in the stage adaptation of LORD OF THE FLIES in 2015. Additionally, the principal cast includes a few NVA debut actors: VAN ANGELO as Collins, SHANNON MCCARTHY as Maureen, JUWAN STANFORD as Benny, and BRENNEN WINSPEAR as Mark. SHELBY GARZA\*\*, GRIFFIN HANSON\*\*, TYLER MARTINEZ\*\*, EMELYSSE PAEZ\*\* will complete the vibrant and dynamic ensemble. TOMMY TRAN and MAYA EFRAT will appear as swings.

"I feel compelled to tell the story of RENT because it's not just a period piece; it's a mirror. It shows us the beauty and heartbreak of living authentically in a world that isn't always kind. It's a story of people who choose love, creation, community, and hope." says Brennen Winspear, who will play Mark.

"I am so excited to return to NVA for this beautiful show! Rent reminds us all how important it is to lean on our community during difficult times. As well as not waiting for tomorrow, but instead taking advantage of today." says Josh Bradford, our Roger.
